MEMORANDUM

Background

The District has received a formal 10-day notice that the union will initiate a strike on December 15, 2025. To maintain safe clinical care and uninterrupted core operations during the strike, administration has conducted a focused assessment confirming that the action will create significant operational, staffing, and financial demands on the District. Contingency staffing agencies require advance notice and fully executed agreements before they will mobilize clinical and non-clinical personnel. Preapproved authority is necessary for the District to secure the staffing resources required to support patient care and essential services during the strike period.

Discussion

Preliminary cost estimates for securing a full contingency workforce show a projected range of \$650,000 to \$900,000 for a five-day strike scenario. While the Union has provided advance notice of a one-day strike for the Technical Unit and a four-day strike with the RN Unit, the proposed contracts provide for a five-day minimum commitment. These estimates include staffing agency fees, travel, lodging, overtime, internal support, and potential security enhancements. Agencies may also impose higher rates during peak demand periods or short-notice activations.

In addition to contingency staffing, a strike could necessitate unplanned operational expenses that exceed the CEO's current spending authority. These may include additional security services, communications support, temporary operational resources, and other emergent needs. To ensure timely responses and uninterrupted patient care, temporary flexibility in spending authority is needed, with safeguards in place for Board oversight.

Recommendation

- 1. Authorize the CEO to execute a contingency workforce contract for strike coverage in an amount not to exceed \$900,000.
- 2. Authorize the CEO to exceed the District's standard spending authority by up to \$100,000, with approval from the Board President, through December 31, 2025. The full Board will be notified as soon as possible of any expenditures made under this temporary authority.

These recommendations will ensure the District is able to respond effectively should a strike occur and maintain safe, continuous operations for the community.
